Applicants from the Government /Local Governmental Departments/Corporations/ Statutory Bodies should channel their applications through the heads of their institutions.

- Should be physically and mentally fit to perform the duties entrusted to the post and to serve in any part of the island.
- Director General & Director Finance:- Age should be not less than 35 years and not more than 55 years. The upper age limit will not apply to the internal candidates
- Assistant Director Human Resource Development:- Age should be not less than 22 years and not more than 45 years. The upper age limit will not apply to the internal candidates
